General Terms

1. **Applicability.** The terms contained herein apply to each Client.
2. **SaaS Clarification.** For clarity, the features and functionality to be provided by Benevity, as described in the [Product Descriptions](https://go.benevity.com/hubfs/website/client-and-prospect-files/Benevity-Product-Descriptions.pdf)¹ and/or the [Service Descriptions](https://go.benevity.com/hubfs/website/client-and-prospect-files/Benevity-Service-Descriptions.pdf)², as applicable, include standard features and functionality generally offered by Benevity to other clients across our multi-tenanted SaaS platform (by design). The provision of any features or functionality that are not generally made available by Benevity to other clients will be subject to additional agreement between the Parties.

- are registered and in good standing with their relevant local governing authorities.
- b. **"Foundation"** means third-party charitable foundations that work with Benevity and that are registered in the jurisdictions in which they are established and which utilize a "donor advised fund" or similar model.
 - c. **"Funding Entity"** means the Global Online Giving Foundation, a third party non-profit organization that works with Benevity.
